Women's Empowerment (WE) funds economic empowerment programs including small business loans, training, education, and other vital poverty alleviation strategies for women experiencing poverty. More on Sched O

Business services and entrepreneurship training for refugees, immigrants and low-income women in San Diego enrolled in the WE STAR Program through grants to the International Rescue Committee in San Diego. In 2021, the program enrolled 122 women clients and provided training sessions to about 232 women. 88 new women-owned business were started or strengthened and expanded. An estimated 70 jobs were created or sustained from these activities.

4b (Code:) (Expenses \$ **40,100.** including grants of \$ **40,100.**) (Revenue \$)

Grants to Nyaka Global provided funds for loans for poor grandmothers who are each raising and supporting an average of six grandchildren in conditions of dire poverty. In 2021, WE funds supported loans to an estimated 42 grandmother groups averaging \$3,401 each group and benefitting approximately 3,463 grandmothers. 938 grandmothers received agricultural hoes to help them with farming. 674 grandmothers received water tanks. 768 members were given vocational training on good methods of farming, handicraft production, health and sanitation improvement, and most especially on COVID 19 standard operating procedures

To cover the costs of healthcare products and transportation to support the rural poor in Haiti. WE funding allowed new Community Health Entrepreneurs (CHEs) to be trained and start the community health store and community education. In addition the CHEs have acquired the training to screen children for malnutrition, and adults for high blood pressure. The program has expanded to 38 branches out of 44 throughout Haiti and has 1098 active CHEs. The program has continued and expanded in spite of the numerous natural and political challenges that impacted Haiti in 2021

Funding to Via International provided funding for microloans and educational programs for women who are in or at risk of entering the sex trade industry in Tijuana, Mexico, and for women who have recently immigrated or been deported to the area. The program provides resources to increase economic and social empowerment for women disproportionately burdened by poverty, lacking education and access to employment, poor health outcomes, violence and other human rights violations. WE funds in 2021 were used to support staff that are operating the microloan program and organizing new groups of women who are participating in nutritional education and community building programs, precursors to the establishment of loan groups. Existing two loan groups continued to operate successfully and women from the deported mother's community, mixteco women from southern Mexico have organized into groups to begin the process of building community.
